

### U.S. Law Is Beneficial To Those Entities That Can Demonstrate Due Diligence/ Appropriate Vetting

- 1) Asking the right questions
- 2) Having a formal, written screening process
- 3) Periodically updating your Vendor
  Selection Process (VSP) and re interviewing you vendors
- Using a 3<sup>rd</sup> party intermediary (DMC, Receptive Tour Operator or Transportation Broker) does not eliminate your responsibility to exercise due diligence







### **Vendor Selection Questions**

- 1) Insurance Limits/ Policy Types
- 2) Safety Record Claims/Accidents
- 3) Driver's Records Minimum
  Experience Requirement/Safety/
  Training/Testing and Alcohol &
  Substance Screening
- 4) Type of Vehicles
- 5) Age of Vehicles
- 6) Maintenance of Vehicles
- 7) Equipment Vans with Seat Belts
- 8) Quality Control and Feedback Plans
- 9) Crisis and Emergency Plans
- When transportation is secured by 3<sup>rd</sup> party, that 3<sup>rd</sup> party should be notified of and complete your VSP process with respect to that activity.









## **Rental Vehicles & Ride Share Applications**

- Rental Vehicles (without a driver) Generally carry State required Minimum Financial Responsibility – Florida \$10,000
- Rideshare Applications No Vetting or Due Diligence
